Dear Student:

Your Turn Intern Expo & Celebrity Fest is funding internship grants that will provide undergraduate and graduate college students, as well as recent college grads with financial aid, while they complete internship experiences!

Your Turn Intern Expo & Celebrity serves as the major funder of the internship grant / financial aid fellowship awards. Millennium Momentum Foundation, Inc. (MMF), the benefiting charity of Your Turn Intern Expo & Celebrity Fest, manages any applicable day-to-day direct service delivery associated with this opportunity. MMF reviews applications, scores eligible candidates, selects & notifies internship grant recipients, and more applicable to our funded internship grant awards.

### **APPLICATION CYCLES & DEADLINE**

Applications will be accepted in separate cycles during Spring 2019, Summer 2019 & Fall 2019, of which the application deadline for the upcoming cycle is captured below and on the application itself for your access. Additional cycles may be made available, as approved Your Turn Intern Executive Committee. A separate application will be posted on our website for each cycle with a designated deadline therein. Applicants can apply for more than one cycle, but cannot receive a grant more than 1 time in a given calendar year.

### **SPRING 2019 APPLICATION DEADLINE**

## **GRANT AMOUNT**

Applicants will not apply for a specified grant amount. Instead, applicants will submit application with the understanding that Your Turn Intern Committee will determine the individual grant amount awarded to each selected applicant ([ranging from \\$1,000.00 to \\$4,000.00](#)). Various factors will determine the amount of internship grants that will be awarded to selected recipients including, but not limited to length of internship placement term, student class standing (grad or undergrad), employer partnership status, college campus-based student leadership organization partnership status, student financial need, and more.

## **ELIGIBILITY**

Applicant must meet the following basic eligibility criteria to be considered for Your Turn Intern funded grant award / financial aid fellowship;

- All majors and all career fields are considered and eligible (private sector, public sector, nonprofit sector, etc.).
- Must be hired for an internship in one of the following regions; Southern California, Silicon Valley, Miami, Atlanta, Chicago, or New York. Hire letter from employer required as application supplement.
- All grant recipients will be “conditionally selected” based upon information provided in their submitted grant application on the basis of academic merit, financial need, demonstrated leadership potential, and commitment to improve the quality of life in regions targeted by Your Turn Intern Expo & Celebrity Fest, and disbursements will be contingent upon verification of conditions being met during placement as follows, unless otherwise customized and agreed upon in writing to fit Your Turn Intern Expo & Celebrity Fest specific college campus partner expectations or employer partnership expectations;
  - Must be a student enrolled full-time at, or recently graduated from, a community college or 4-year university in one of the following regions; Southern California, Silicon Valley, Miami, Atlanta, Chicago or New York. Official enrollment verification / transcript will be requested.
  - Must have a cumulative 3.0 GPA at the time of internship grant application, and must maintain a cumulative 3.0 GPA during internship placement term (Fall & Spring Semesters Applicable Only). Official transcript will be requested for satisfactory academic performance verification as a condition of grant disbursement.
  - Must demonstrate satisfactory performance during internship placement term. Formal performance evaluations from intern’s Immediate Supervisor during internship placement term will be requested for placement satisfactory performance verification as a condition of grant disbursement.
- Typically, grants are disbursed during scheduled periods (half-way thru term & at end of term) after verifying conditions being met, but disbursement cycles may be further customized by Committee, as needed, based on intern placement terms, college / university academic calendars, academic & professional performance accountability

measure alignment and more. All interns must complete entire internship placement term, of which there are no partial disbursements to any extent provided to interns that discontinue placement at any point during placement.

### **PRIORITY CONSIDERATION**

- All applicants submitting applications will be considered for selection. However, please note that the following applicants will be prioritized for our grant funding, as established by Your Turn Intern Executive Committee;
  - ✓ Applicants that have been hired to intern at companies, agencies, institutions, and chambers of commerce that partner with Your Turn Intern Expo & Celebrity Fest and exhibit at Your Turn Intern Expo. These applicants will be allocated an **additional 20 bonus points** in the application review and scoring process. Proof of hire in the form of copy of employer hire letter required to be submitted with grant application.
  - ✓ Applicants that have graduated and/or received certification from a current or prior year Millennium Momentum Foundation Leadership Development Institute (LDI) or Your Turn Intern Expo Professional Development Series. Students that have graduated from LDI will be allocated an additional **15 bonus points** in the application review and scoring process. Students or recent grads that have completed the Professional Development Series onsite at Your Turn Intern Expo will be allocated an additional **5 bonus points** in the application review and scoring process. Proof of LDI graduation or Professional Development Series completion in the form of copy of certification is required to be submitted with grant application.
  - ✓ Applicants that have been selected and honored at the Your Turn Intern Expo's "30 Under 30" Most Powerful Intern Award Ceremony. These applicants will be allocated an additional **10 bonus points** in the application review and scoring process. Proof of show recognition in the form of copy of recognition selection letter required to be submitted with grant application.
  - ✓ Applicants that are members in good standing with partnering college / university-based student leadership organizations. These applicants will be allocated an additional **10 bonus points** in the application review and scoring process. Proof of partnership in the form of letter of recommendation from student organization President or Committee Chair is required to be submitted with grant application, unless otherwise customized in writing to fit partnership mutual expectations.
